1. All Applicants must submit the following:

- Completed Application Form
- ☐ A completed Medical Self Declaration Form, or completed Physical Examination Package as follows:

National Kart Licences:

Applicants up to the age of 50

At the time of application for a competition licence, drivers shall submit a completed and signed Medical Self Declaration form. If the application is under the age of majority in the province of residence, the Medical Self Declaration must also be signed by a Parent/Guardian.

Applicants age 50 and older

All licence application 50 years of age and older are required to submit a Physical Examination Package every two years. In the years that a Physical Examination Package is not required, a Medical Self Declaration is to be submitted.

Race and Rally Licences

First Time Applicants

All first time Licence applications must submit a Physical Examination Package.

International Licences

A Physical Examination Package is required every year. All pages of the package must be completed.

Applicants under the age of 45

A 12-lead electrocardiogram is required every two years. A consultation with a cardiologist specialist maybe required at the request of your physician.

Applicants age 45 and older

A consultation with a cardiologist specialist is required every 3 years. If the doctor deems it useful, depending on the possible symptoms and signs, he may ask for further investigations including a stress test.

National Race Licences

- every 5 years between ages 9 & 35
- every 2 years between ages 36 & 59
- every year over 60 years of age
- Medical History Self-Declaration Form to be completed and submitted on the years when a Physical Examination Package is not required.
- Copy of most recent or current competition licence
- Proof of recent competition experience.
 - Applicants are responsible to supply either competition or series results.
 - Note: Links to websites will not be accepted.
- ☐ A high-resolution head shot photo in JPEG Format
- Appropriate fee
- Proof of Club Membership (kart license applicants)
- 2. New Race Applicants must submit the following:
 - □ Copy of racing school certificate with Chief Instructor's endorsement.
 - Professional, Regional and Club Racing Schools recognized by Sports Development Group (GDS) will only be accepted
 - Proof of Age (i.e.: Copy of a Birth Certificate, Drivers Licence or Age of Majority Card)
- 3. New Kart Applicants must submit
 - Proof of Age (i.e.: Copy of a Birth Certificate, Drivers Licence or Age of Majority Card)
- 4. Applicants wanting to Upgrade their licence within the same year

Note to All Applicants

- Licences are valid from date of issue to December 31 of the calendar year. Licence Fees are not pro-rated
- Allow 15 working days for receipt of licence by regular post. If application is received less than 15 days prior to event, an additional fee of \$100.00 will be charged.
- If you require your licence returned by Courier include the fee below with your application.
- Competitors upgrading a current Regional Race Licence or CARS National Rally Licence to Sports Development Group (GDS) National or International licence, prior to July 1st, will be charged the full licence fee. If the application is made after July 1st the upgrade fee of \$200.00 will apply.
- If you are applying for an upgrade to a current Sports Development Group (GDS) Race Licence, the upgrade fee of \$200 will apply at any time.
- It is the responsibility of the Applicant to provide accurate information when applying for a licence.
- Licences will not be issued if all required documentation is not submitted with this application. Fees paid at the time of submission will not be refunded
- Sports Development Group (GDS) has the right to refuse any application for not meeting the criteria as stated in the Criteria for a Competition Licence, as well if the required documentation stated on page 1 is not received.
- Sports Development Group (GDS) has the right to require further information to proceed with any application received. This may require additional information required by the Applicants physician.
- Sports Development Group (GDS) has the right to share information with affiliated Regions, Clubs and any Sports Development Group (GDS) commissions including the National Medical Committee.
